Announcement of the Defence Technology Institute

No. **25** / 2024 (B.E. 2567)

Subject: Policy of Not Accepting All Kinds of Gifts and Presents from Performing Duties
(No Gift Policy)

The Defence Technology Institute (DTI), is a juristic person and a public organization under the supervision of the Minister of Defence, the Kingdom of Thailand. Pursuant to the Defence Technology Act 2019 (B.E.2562), the Institute has been authorized to conduct research and studies in the field of the defence industry as well as to promote and support Thailand's defence industry capabilities. These efforts are in line with the Royal Thai Government's policy to promote and support the development of the defence industry of the country.

In order to strengthen the organizational culture as well as honesty and integrity in carrying out tasks with virtue and ethics, performing duties without conflict of interests, and preventing corruption, the Defence Technology Institute has set up the Policy of Not Accepting All Kinds of Gifts and Presents from Performing Duties (No Gifts Policy). The Defence Technology Institute is a public organization whose officials, personnel and persons who perform other duties in a public organization under the Defence Technology Institute administration do not accept all kinds of gifts and presents from performing duties as follows;

1. Defence Technology Institute officials, personnel, and persons who perform other duties under the Defence Technology Institute administration refrain from accepting all kinds of gifts and presents, or any other benefits while/before/after performing duties that will result in corruption and misconduct;

2. Defence Technology Institute officials, personnel, and persons who perform other duties under the Defence Technology Institute administration refrain from giving all kinds of gifts and presents, or any other benefits, during and after performing duties;

3. Defence Technology Institute officials, personnel, and persons who perform other duties under the Defence Technology Institute administration shall not seek all kinds of gifts and presents or any other benefits before, during or after performing duties;

4. Expression of congratulations, best wishes, welcome or condolence in traditional occasions should be done by signing blessing cards, blessing books, condolence cards, or using social media instead of giving things;

5. Defence Technology Institute officials, personnel, and persons who perform other duties under the Defence Technology Institute administration are authorized to inform all outsiders of the Policy.

This announcement shall be informed and observed accordingly.
